Notice on Establishment of a Special Committee

As announced by Makino Milling Machine Co., Ltd. (the "Company") in the "Notice Regarding Scheduled Commencement of Tender Offer for Shares of the Company by Nidec Corporation" as of December 27, 2024, on the same date Nidec Corporation ("Nidec") announced a scheduled commencement of a tender offer for the Company's common shares. On the same date, the Company received from Nidec a "Letter of Intent Regarding Management Integration Aimed at Maximization of Corporate Value" (the "Letter"). In the Letter, Nidec has proposed a tender offer for the Company's shares with the aim of making the Company a wholly-owned subsidiary of Nidec (such proposal by Nidec in the Letter to make the Company its wholly-owned subsidiary, the "Proposal").

In response to the Proposal made by Nidec, the board of directors of the Company, at its meeting held today, has decided to, in considering the appropriateness and fairness of the terms and procedures of the transaction, including the pros and cons and structure of the Proposal, from the perspective of enhancing the corporate value of the Company and the interests of the general shareholders, establish a special committee (the "Special Committee") for the purpose of eliminating arbitrary decisions by the board of directors of the Company and ensuring fairness, transparency and objectivity in the decision-making process.

The members of the Special Committee are as follows. None of the members has any interest in Nidec.
